#### Workshop Description:

Can social work professionals work with clients that they know from outside of the job? Can you barter with clients for your services? Social workers are charged with the legal and ethical responsibility to maintain professional boundaries, but the obligation isn't always so easy to discern. This course brings real-world context to ethical concerns often experienced by professionals in practice in maintaining appropriate professional boundaries. This course will provide a framework to contemplate ethical dilemmas and make informed decisions that insulate professionals from legal liability while protecting clients from harm.

As of April 1, 2023, a NYS licensed social worker is required to complete 3 hours of continuing education course work in appropriate professional boundaries in each 3-year registration period. This 3 Credit course meets that requirement.

#### Workshop Description:

We all became social work and mental health professionals for a reason: we want to help. However, helping can be complicated, especially when it comes to families. It's hard to distinguish problematic parenting from child maltreatment. Poverty and substance use disorders can make evaluating a situation more difficult. As social work professionals, it is complicated, because social workers are legally obligated to report certain suspicions to child protective services.

This session was developed to help you understand the considerations you should make when you have a concern about someone's parenting. We'll explore common case studies to identify practical strategies for intervention with families that meet our legal and ethical obligations.

Workshop Description: No matter what area social workers and other healthcare practitioners specialize in, being knowledgeable about different abilities and those who live their lives with them will greatly benefit the client and impact the therapeutic alliance. This workshop will explore barriers women with different abilities face within patient advocacy, healthcare, lack of accessibility, ableism, inability to obtain the right tools, adaptive equipment and more. Discussion will focus on the impact on a woman's education, ability to obtain transportation and its impact on vocation, independence, sense of self, travel and taking care of a family.

Our Instructor will provide resources about available tools and types of equipment to facilitate independence, effective gadgets and clothing, and means of transportation. There will be engaged discussion on policies, supporting patient/client advocacy, working with female clients to find their voice, navigating their niche, preventing systemic marginalization, fostering gender equality, and standing up against discrimination and barriers.
