Impacts of Maternal Incarceration: A Person-Centered Approach in Clinical Practice with Children

Workshop Description:

More than 5 million children have been burdened by parental incarceration, 1 in 14 are currently experiencing parental incarceration (Prison Policy, 2018). The emotional and social strain endured by children of incarcerated parents is a contributing factor to psychological maladaptation. Research depicts children that have experienced maternal incarceration are 2.5 more at risk of incarceration over the course of their lives, than children who experienced paternal incarceration. This presentation is aimed to provide practitioners with knowledge to guide their work by supporting their ability to identify this population, confront stigmatization, and serve them through a person-centered approach.

What does it mean to be a LGBTQIA+ inclusive practitioner? How do we build rapport with LGBTQIA+ clients and their support systems? This interactive workshop will be an opportunity to unpack questions while acknowledging that our journey of building awareness and empathy may happen at the same time we are working with clients experiencing their own exploration of gender and sexuality. In this workshop participants will broaden their understanding of LGBTQIA+ inclusive language surrounding gender and sexuality, become more sensitized towards the dynamics of family systems when working with LGBTQIA+ clients, learn about best practices for supporting LGBTQIA+ clients and their families, and gain an understanding of the complexity of issues and the sensitive nature of working with LGBTQIA+ clients.

Workshop Description:

Statistically it is known that adverse childhood experiences (ACEs) before the age of 18 increases risk of not only developing social and emotional challenges but also increases risk of substance use and autoimmune diseases. Research also shows that intervening early with effective trauma treatment can mitigate these risks. In this two-part comprehensive workshop we will expand the way we define trauma so that we are more able to recognize it in the children and families we treat and gain tools to assess trauma symptoms in children ages 5-11. Participants will learn evidence based trauma treatment practices that can be used with the child and caregivers so that the family unit can heal and learn coping tools together.

Workshop Description:

This workshop will introduce some of the foundational concepts of working with trauma from a somatic perspective – a body-based approach to healing trauma. It will include an overview of how working with trauma is not an exploration of a story or narrative but rather an exploration of how events impact an individual's body. Participants will learn about various somatic interventions, as well as simple observations of a person's body that can provide deeper insight into how traumatic events have impacted them. There will be discussion of the body's natural tendency toward healing and how practitioners can support that process.

Workshop Description:

More than half of child maltreatment suspicions do not get reported to child protective services. Contributing to the quandaries professional reporters face when making the decision to report is concern for infringing on family autonomy. These concerns largely relate to the ethical conflict between protecting children and respecting parental rights. This session will explore the history and ethical application of parental, child and family rights schemas in an effort to help prepare professional reporters of suspected child maltreatment with the tools to report, when necessary, and respect family autonomy whenever possible.

Workshop Description:

70% of adults have experienced some type of traumatic event at least once in their lives. This means that when an adult enters therapy there is a high likelihood that the symptoms they are experiencing are trauma-related. In addition, when we apply an anti-racist and equity lens to our practice, we are more able to identify the impact of racial and gendered trauma. In this two-part workshop participants will gain the tools to assess for both traditional and more nuanced trauma symptoms. There will be a focus on evidence-based trauma treatment practices to better address the issues that adults with a trauma history typically experience such as difficulties with emotional regulation, forming and maintaining healthy relationships, resolving conflict, and assertive communication.
