#### Workshop Description:

Social and emotional learning (SEL) is based on the understanding that the best learning emerges in the context of supportive relationships that make learning challenging, engaging, and meaningful. Social and emotional skills are critical to being a good student, citizen, and worker. Many risky behaviors (e.g., drug use, violence, bullying, and dropping out) can be prevented or reduced when integrated efforts are used to develop students' social and emotional skills. Many of our younger clients struggle with deficits in social skills and difficulty with regulating their emotions. These deficits often impact the quality of their relationships and impair their ability to succeed in many areas of life. This course will provide social workers or those in supportive roles with strategies to give children and adolescents the skills needed to become knowledgeable, responsible, caring and contributing members of society. This course will draw on information and research from Collaborative for Academic Social and Emotional Learning (CASEL). CASEL provides evidence based practice designed to increase social competencies in children and adolescents.
