Getting Here

By Car

From New York City, take the Long Island Expressway (LIE, I-495) east-bound from the Queens Midtown Tunnel in Manhattan or the Throgs Neck Bridge or Whitestone Bridge in Queens to exit 62, and follow Nicolls Road (Route 97) north for 9 miles. The main entrance to the University is on the left. To find the campus via GPS, enter the address "100 Nicolls Road, Stony Brook, NY 11790."

By Train

Take the Long Island Railroad's Port Jefferson line from Penn Station in Manhattan to Stony Brook. The LIRR station is at the north end of the campus; bus service to the central campus is provided. Trains to and from Penn generally require transfers at Jamaica or Huntington. Hicksville is also a transfer point on some lines. Find schedule and fare information here.

By Ferry

Car ferries cross Long Island Sound at Bridgeport, Connecticut to Port Jefferson, Long Island. Take Route 25A west to Nicolls Road, and turn left on Nicolls. The University entrances are the first three intersections you come to. From New London, Connecticut to Orient Point, Long Island, take Route 25A west to Nicolls Road and proceed as above.

PARKING:

The Administration Parking Garage is located opposite the Wang Center. Please bring the parking ticket to us and we will validate it to cover the parking fee.

If parking is not available in the Administration garage, a metered parking lot is located across from the Wang Center on the east side of Circle Road.

Ambiguities and unintended consequences regarding changes in national and state marijuana policies will be the focus of this half day conference. The legalization of recreational marijuana in some states and the approval of medical marijuana here in New York has created controversy and concern over the impact such policy shifts could have on individuals, families and communities.

A law enforcement-driven approach to marijuana has come with little benefit and with a high price for many communities, yet many feel that legalization goes too far. Medical marijuana has the potential to provide relief to individuals who suffer from certain illnesses, including seizure disorders, yet at the same time, medical marijuana poses risks to the public health and safety of those who may misuse this substance.
