• Community food-share; provides groceries, clothing, books, household goods, and other necessities to fight social, economic and environmental oppression by sharing with our community. We adhere to a community-based, all volunteer, non-hierarchical, decentralized power structure. We are all neighbors, equally-valued, and responsible to work toward increasing social good. Anyone is welcome to attend. No identification, including proof of immigration status, number of dependents, or means-testing—because "food is a right, not a privilege"—is required. Our aim ("Solidarity Not Charity") is fostering linkages, support, and social connection, while creating space where those experiencing need may regain their sense of hope and power. Concomitantly, we are "building new alternatives from the ground up" by increasing cooperation, equitable distribution of resources/power, empowerment, individual agency, and life-affirming societal values—and ending hunger.

Service includes donation coordination, collection, and transport, food-share set-up, organization, and management, volunteer recruitment, training, and supervision, community outreach and organizing, grant identification and application, resource networking.
