## Mandatory Professional Licensure Disclosure

Dear Master of Social Work Student:

New York State prides itself in the high quality of its licensed and certified professionals. For the protection of its citizens, each license and certificate has requirements that individuals must meet in order to be licensed or certified in New York State. SUNY's academic programs leading to licensure or certification are carefully designed to meet and exceed these State requirements. This is a role SUNY plays in protecting the public. Other states frequently have their own requirements, so if your goal is to practice in another state, this disclosure will help you check to see what that state requires.

Per U.S. Federal Regulations, §668.14 and §668.43, and in compliance with the State Authorization Reciprocity Agreements (SARA Policy Manual, version 24.2), SUNY Stony Brook provides the following disclosure related to the educational requirements for professional licensure and certification.

This Disclosure is strictly limited to SUNY Stony Brook's determination of whether its Master of Social Work educational program, if successfully completed, would be sufficient to meet the licensure or certification requirements in a State.

This disclosure does **not** provide any guarantee that any particular state licensure or certification entity will approve or deny your application. Furthermore, this disclosure does **not** account for changes in state law or regulation that may affect your application for licensure that may occur after this disclosure has been made.
